11. Re-Licensure Application review

Therefore, the Board needs to hold to the ND laws and rules stating that she needs to provide 150 hours of documented continuing education. The Board will keep the application open for a year to give the applicant the opportunity to submit the appropriate documentation. If documentation is received, the Board will hold a special meeting to review the new information.
