#### **II. Century Code Review**

- The Board discussed subsection 2 of section 43-37-02 of the ND Century Code
- Subsection 2 of section 43-37-02 does not have the word "managing" which is a
  key word for reimbursement with certain insurance companies. There have
  been recent changes with 3<sup>rd</sup> parties paying for hearing aids along with changes
  made by the AMA regarding who is a qualified healthcare professional.
- It was advised that 3<sup>rd</sup> party insurance considers hearing aid checks to be "managing" and this word needs to be included in the audiology scope of practice for reimbursement.
- Courtney Olson made the motion to add "managing" in subsection 2 of section 43-37-02 of the ND Century Code.

#### III. Interstate Compact

 AAG Matt Menge spoke to the Board regarding his discussion with Representative Froelich concerning an Interstate Compact.

 Currently, North Dakota is not eligible to join an Interstate Compact because to join, ND laws need to require a post-secondary clinical experience under supervision.

 To be part of the ASLPC Compact, the Board will need to change the Century Code to require a provisional license in a clinical fellowship for the 1st year.

Matt Menge advised that in 2022 a federal bill took effect and it focuses on the portability of a professional license. This bill allows the portability of a professional license held by service members and their spouses. If a service member has a professional license from another state, they need to be granted licensure in ND upon submitting the proper documentation.

Other challenges with joining the compact:

Precuring the necessary software

How the decision-making process is developed

Each state receives 2 delegates who are assigned to the "Compact Commission".

 The Compact Commission acts in a "quasi legislative" capacity and sets rules and bylaws

 If there is a conflict between the ND Century Code and the compact, the compact will prevail. The constitutionality of this is being litigated.

The interests and concerns in small states are potentially different than those of large states. For example, mandating the same data systems. This would be fiscally challenging for smaller states.

- The ND Century Code would need to be changed if the compact were to pass. Some changes would be as follows:
  - The authority for the board to have subpoena power
  - Criminal record checks on every applicant because this is mandated in the compact.
- Matt Menge recommended that the Board not make a decision regarding the Interstate Compact. Instead, this needs to be deferred to the ND legislature. However, the legislature will need to know about the statutory challenges the compact will present.

- The Board reviewed and discussed a document forwarded by a potential SLPLA applicant.
  - The ND Laws/rules state that the 100 hours of clinical experience needs to be completed under the guidance of a licensed speech-language pathologist. The person who signed the document is not a licensed speech-language pathologist.
  - Robyn made the motion Brian draft a letter requesting clarifying information on the exact position and title of his supervisor of the 100 hours of hand-on clinical hours.
