- SB2203
 - Bill combining NDSBE Aud & SLP with the Hearing Aid Specialist Board.
 - Hearing was held on January 21st 2025
 - The Committee will take action on Wednesday January 29th 2025
 - The committee requested that both Boards meet and discuss potentially combining the Boards and what would need to be change for this to occur.
 - The Board discussed the bill with members from the Hearing Aid Specialist Board.
 - Efficiency would be severely hindered due to working with 2 sets of Administrative Rules
 - There could be a significant financial burden to the NDSBE Aud &SLP.
 - NDSBE discussed adding a page to the website for the Hearing Aid Specialist Board
 - Robyn Zeltinger made the motion to have Brian explore the feasibility and cost associated with adding a single page to the website and relay this information to the Hearing Aid Specialist Board so they can review and vote on this information.
 - Krystal Mann seconded the motion
 - Roll call vote: All Ave
 - The Board discussed relaying specific information to the committee chairman:
 - Krystal Mann made the motion to relay the information below to Senator Barda. Marin Almer seconded the motion.
 - Request for a "do no pass" recommendation because the bill will require the century code to be repealed and replaced for both NDSBE and the Hearing Aid Specialist Board
 - NDSBE is currently very efficient and, in order to help the Hearing Aid Specialist Board with efficiency, NDSBE will allow them to utilize a page on their existing website.
 - There will be communication between both Board's during the interim. They will explore ways to make combining efficient and financially feasible.
